RESOLUTION NO. 24070901
RESOLUTION DECLARING EMERGENCY/DISASTER

WHEREAS, Moody County, South Dakota, has suffered severe damage from flash flooding due to heavy rains over the last four weeks, and

WHEREAS, the following conditions exist in Moody County as a result of that disaster:

- Washed out culverts and roadbeds on public roads; and
- Soft roads due to setting water; and

WHEREAS, the following factors contributed to the damages in Moody County:

- High river levels and ground saturation; and
- Flash flooding with over 6 to 10 inches of rain falling throughout the County; and

WHEREAS, Moody County has committed all available resources, and taken all possible actions, within its jurisdictional boundaries to combat and alleviate the disaster, however, local resources are not adequate to cope with the situation.

NOW THEREFORE, BE IT RESOLVED: That the Board of County Commissioners of Moody County declares a state of emergency, and

BE IT FURTHER RESOLVED: We, the Board of Commissioners of Moody County, respectfully petition the Governor of South Dakota and the President of the United States to provide with all dispatch such state and/or federal remedies proper for the alleviation and remediation of/from this disaster and state of emergency.
